We are happy to invite you to the 5th Document Freedom Day that the Greens/EFA is organising with Free Software Foundation Europe to support their campaignhttp://documentfreedom.org/. In this seminar we will present and discuss the study *"Ensuring utmost transparency - Free Software and Open Standards under the Rules of Procedure of the European Parliament"* commissioned by the Greens/EFA on the implications of Rule 115 with regards to ICT. Under that rule, the Parliament has imposed upon itself a commitment to conduct its activities with the utmost transparency. The study concludes that ensuring this "utmost transparency" is not only an essential procedural requirement but actually a fundamental democratic principle which brings precise duties. The study also emphasizes that the Parliament should whenever possible make Free Software and Open Standards mandatory for all systems and data used.
