## Whistleblower protection in Europe

### Greens/EFA roundtable

The need to protect whistleblowers is increasingly recognised at both international and national level, and the EU institutions are pushing forward on the issue:

- The European Commission has recently [launched a public consultation](#) on the issue of whistleblower protection and is [undertaking an](#) impact assessment to ascertain to what extent the EU might be able to legislate on the matter.
- The European Parliament recently adopted a [report by the Budgetary Control Committee](#) on the protection of whistleblowers and the Legal Affairs Committee is [about to draft a report](#) of its own.
- The Financial Affairs Council of the European Union has [called for EU action on the matter](#), and the Justice and Home Affairs Council has whistleblower protection on its agenda for 27 and [28 March](#).

In this context, MEPs Pascal Durand, Benedek Jávor and Julia Reda are organising a high-level roundtable to gather together MEPs, Commission officials and representatives from various different sectors: Trade unions, NGOs, journalists' organisations, media publishers and business representatives.
