Gender-based violence (GBV) is one of the most systematic and widespread human rights violations in the world, claiming thousands of lives every year even before the pandemic.

Under COVID-19, it has surged worldwide into a shadow pandemic. Yet, the European Union still has no directive obliging its member countries to put an end to gender-based violence.
