Greens/EFA priorities and events 5-9 October 2009

Looking beyond today's Irish referendum on the Lisbon Treaty, Greens/European Free Alliance priorities from the EU agenda and its events for next week are listed below. One press conference is planned, on Wednesday on the topic of press freedom in Italy.

Greens/EFA agenda priorities

Tuesday, 6 October 2009

A joint meeting of the EP foreign affairs and development committees will vote to shortlist three candidates for the institution's **Sakharov Prize for Freedom of Thought**. In the first round, the Greens/EFA Group nominated three activists from the Russian fundamental rights organisation 'Memorial'.

Wednesday, 7 October 2009

The EP plenary will vote to create a Parliament committee dedicated to issues related to the **financial crisis**.

Thursday, 8 October 2009

The EP plenary will vote on two resolutions ¶ on the effects of the crisis in **developing countries** and on the **G20 summit**.

A joint meeting of the legal affairs, constitutional affairs and civil liberties committees will examine the far-reaching **Stockholm programme**.
