On 17th December, the European Parliament's environment committee voted to endorse an agreement on a new scheme for the authorisation of genetically-modified organisms in the EU. The Greens voted against the new scheme, as it would rationalise decisions about GMO cultivation instead of reforming the risk assessment process for GMOs, which is urgently needed

EU Sustainable food strategy : Join the Growing call for action!

On 11th December, at the final [conference](#) on the LiveWell project held its last conference to conclude the first phase of this project. On this occasion organisations taking part to the project called participants to the event to sign up LiveWell call to action urging the European Commission to:

- Present the Communication 'Building a Sustainable European Food System' within the first half of 2015.
- Develop a clear EU policy strategy and implementation plan to build a sustainable, healthy and climate-friendly food system by 2030.
- Facilitate cooperation between European stakeholders from different sectors to encourage the adoption of healthy and sustainable food consumption patterns.

Stakeholders can sign up to the call to action until 30 January, after which it will be sent to the Commission.

This action from civil society complements the coordinated action of MEPs from the Greens/EFA Group and other political Groups to call for the publication of the EC Communication. Several members recently signed a letter urging the Commission to take action on the issue of sustainable food. Let's hope this joint action will be positively considered by the new Commission. We will face many challenges over the next five years and the publication of this Communication will be considered by MEPs and European citizens alike as a positive step in the right direction for EU food security.

Conference in Lithuania: "Food export markets - obscurity or new opportunities?"

On 10th December Bronis Ropė, Greens/EFA member from Lithuania organised the conference "Food export markets - obscurity or new opportunities?" in the Lithuanian Government in Vilnius. The conference focused on two main issues: the Russian embargo and the African swine fever. The event also raised several discussions about the future of farming in Lithuania. In a country where organic farms were

already very weak because of low farmers' income and low sale on the local market, the Russian embargo made the situation even worse. Today, Lithuanian organic farmers are not sure about their future.

French organic winemaker discharged : one battle against pesticides won

In April this year, Emmanuel Giboulot, organic winemaker from Dijon, was convicted for refusing to use a mandatory treatment on his Burgundy vines as a precautionary measure against 'flavescence dorée' disease, which some have compared to the deadly phylloxera bug that devastated vineyards in 19th Century Europe. The judgement has sparked debate in the French media (and some European and US media) about whether Giboulot was right and allowed to raise once more the problems linked to the use of pesticides, with France being the first user of pesticides in Europe.

On 4th December, Emmanuel Giboulot was discharged by the appeal court of Dijon.
