## **Public health- The Parliament says no to herbicides with bentazone**

On 23d November, the European Parliament rejected the renewal of the authorization of bentazone.

The European Commission intends to renew for 15 years this substance, an active ingredient used in several herbicides, despite the opinion of the European Food Safety Authority (EFSA) and the recommendations of the European Ombudsman. In a non-binding resolution, the Parliament opposed this initiative from the Commission.

## **Glyphosate : the European Court of Justice rules for transparency on access to information on chemicals**

For the European Court of Justice, documents relating to the authorization of pesticides are of superior public interest.

In December 2010, NGOs Stichting Greenpeace Nederland and Pesticide Action Network Europe (PAN Europe) asked the European Commission, to access documents on the first authorization to market glyphosate dating from 2001. But, with the argument to protect intellectual property rights, the Commission had sent only some of the documents on that active substance of the best-selling herbicide in the world. The associations then applied to the Court of Justice of the EU (CJEU) for full access to the documents.

## **GMO cultivation, not here not anywhere**

The European Commission should submit soon to the Standing Committee on plants, animals, food and feed three draft regulations aimed at the renewal of the authorisation for cultivation in the EU of three GM maize varieties. The Standing Committee, composed of experts from Member states, can validate or block the EU Commission's proposal if they reach a qualified majority during the vote. Since last year the situation has changed, as the so-called "opt-out" regulation entered into force. It allows individual Member states to ban the cultivation of a GM plant on its territory even if it is approved at the EU level. But if you believe GMOs should not be grown, then you should make sure they are not grown across the whole EU. Environmental problems caused by GM crops won't stop at the borders!
